

**NEW JERSEY EDUCATION TO EARNINGS DATA SYSTEM ("NJEEDS")
NEW STATE AGENCY PARTNER ADDENDUM**

This Addendum to the Memorandum of Agreement dated November 13, 2017, that establishes the New Jersey Education to Earnings Data System ("NJEEDS") ("MOA") is made and entered into as of the last date of signature below ("Effective Date") by the New Jersey Higher Education Student Assistance Authority ("Entity"),

WHEREAS, Entity wishes to become a party to the MOA and to be subject to the terms and conditions of the MOA; and

WHEREAS, Rutgers, The State University of New Jersey, on behalf of its John. J. Heldrich Center for Workforce Development ("Rutgers") has determined that the inclusion of Entity as a Data Owner and active participant to NJEEDS substantially enhances and materially advances the objectives and purpose of NJEEDS, as outlined in the MOA (Rutgers and Entity are referred to herein individually as "Party" and collectively as the "Parties"); and

WHEREAS, The Parties agree that the Entity's participation in NJEEDS advances the public's interest in a manner that is consistent and appropriate for each Party's status;

NOW, THEREFORE, in consideration of the representations and promises set forth herein, and intending to be legally bound, Entity agrees as follows:

1. All terms and conditions of the MOA, including Appendices, are incorporated herein by reference, and Entity agrees to be bound by the MOA and such Appendices.
2. Entity shall transmit the data elements identified in Attachment A ("Data") to Rutgers to use for NJEEDS. The method of transmission, the frequency and timing of the Data transmissions shall be agreed to by the Parties.
3. The transmission of Data to NJEEDS by Entity, shall be construed that the Entity has reviewed the technical and physical security requirements necessary to receive the Data, and that Rutgers has employed the necessary technical and physical measures to receive the Data to Entity's satisfaction. Upon Rutgers receipt of Data, the terms of the MOA will apply to the Data supplied.
4. This Addendum and the MOA constitute the entire understanding of the Parties with respect to the subject matter hereof and supersede any prior understanding, oral or written, between the Parties with respect thereto. All other terms and conditions of the MOA shall be in full force and effect for purposes of this Addendum. Unless defined herein, capitalized terms shall have the meaning assigned to them in the MOA.
5. The term of this Addendum shall be effective as of the Effective Date and be coterminous with the MOA.
6. If any provision of this Addendum is determined to be invalid or unenforceable, the Parties will negotiate in good faith revisions to the provisions that may be required in order to render the

Addendum enforceable. In the event the Parties are unable to agree to new or modified terms, the remainder of this Addendum will not be affected.


7. Entity, by its duly authorized representatives, for good and valuable consideration as set forth herein, the receipt of which is hereby acknowledged, and intending to be legally bound, do hereby enter into this Addendum as of the Effective Date. The persons signing below represent and certify that each has the right and authority to execute this Addendum on behalf of their respective Party and no further approvals are necessary to create a binding agreement. All Parties hereby represent and warrant that they can fulfill the obligations of this Addendum and that nothing it contains violates any third party obligations any Party may have.



IN WITNESS WHEREOF, the duly authorized representatives of the Parties hereby execute this Addendum as of the date first written above.




